Course Number and Title: PCL389H1F: the Role of Pharmacology and Toxicology in Society

Course description:

PCL389H1F is a community engaged learning course that explores issues surrounding the effects that pharmaceuticals and chemicals have in society. Specifically, it integrates pharmacology and toxicology with social, health and political issues as they relate to drug abuse and addiction. It builds on students knowledge of pharmacokinetics and pharmacodynamics, focusing on various theories and issues associated with substance use disorder. Students are required to interact and work with community partners during the semester (approx 20hrs). Classroom discussions will integrate community experiences with lecture material.

Qualifications: The successful candidate will have a PHD in Pharmacology with demonstrated scholarship in substance use disorder/addictions studies and teaching experience. The preferred candidate will have experience with Community Engaged Learning/Service Learning teaching as an instructor or a graduate student. Familiarity with the issues and latest scientific and health research associated with SUD, addiction and mental health. The individual should be comfortable and have experience with grading student reflection writing assignments as well as grading student oral presentations/debates and written assignments. The incumbent will be required to develop and grade exam questions and work with and oversee two graduate teaching assistants. The candidate will also be required to interact and communicate with

community organizations that partner with the PCL389H course, and will need to manage and oversee student placements at these organizations. Project Management experience a must.

Description of duties: (may include but are not limited to)

- Develop and provide lectures on pharmacology and toxicology, which underlies SUD and addictions;
- stimulate conversation and discussions on various health and drug use policies that are associated with SUD and mental health.
- managing student learning through the LME Quercus
- grading student reflection writing assignments as well as grading student oral presentations/debates and written assignments.
- develop and grade exam questions
- work with and oversee two graduate teaching assistants.
- interact and communicate with community organizations that partner with the PCL389H course, and will need to manage and oversee student placements at these organizations.
- Oversee and work with faculty guest lecturers
