Course Number and Title: PCL3302HF: Ethical Considerations and Regulatory Affairs in Drug Development

Course Description:

This 0.25 module graduate course for students registered in the Applied Clinical Pharmacology (ACP) MSc field of study introduces provides an overview of the ethical considerations and regulatory frameworks governing drug development. Topics include ethical research principles in drug development, appropriate communication of drug-related information, the role of bioethics in shaping pharmaceutical policy, and Canadian and international regulatory requirements for drug development.

Course Schedule: Classes are offered on Fridays from 10 a.m. to noon in September and October 2024

Sessional dates: September 6, 2024 – October 11, 2024 (with grading until Oct. 18, 2024)

Qualifications: Applicants must have completed a PhD in Pharmacology or an MD or related degree and have knowledge of clinical research and drug development, bioethics, and regulatory affairs.

This role involves course administration (e.g., preparing and managing the course learning portal, posting lecture notes, managing student inquiries), lecturing, participation in class discussions, meeting with students, and conducting and grading student assessments.
